P.P.C, in the above mentioned criminal case registered with Police Station Kohsar Islamabad.

Briefly stated, complainant Shaukat Ali Muqadam being father of Mst.Noor Muqadam (deceased) reported the matter to the police P.S Kohsar vide statement Ex.P-A duly recorded by Muhammad Zubair Mazhar ASI (PW-15) stating that on 19.07.2021 at afternoon he went to Gulraiz, Rawalpindi to purchase goat for sacrifice, whereas his wife went to tailor at F-10 Islamabad. When he came back to home at Magrib prayer time, his daughter Noor Muqadam aged about 27/28 years was not present at home. His wife made telephonic call to Noor Muqadam on her cell number which was found switched off. They started searching their daughter and approached to her friends, then his daughter made telephonic call and informed that she was going to Lahore with her friends, will come back within 1-2 days. On 20.07.2021, at noon time Zahir Zakir with whose family the complainant had acquaintance, telephonically informed that Noor Muqadam is not with him. On same day at 10:00pm the complainant received information from Police Station Kohsar about the murder of his daughter, then he rushed to Police Station Kohsar. The police took him to the house of Zakir Jaffar bearing No.07, Street No.60, Sector F-7/4 Islamabad, where he saw his daughter was done to death brutally with sharp edge weapon by separating her head from the body. Upon said complaint initially the FIR Ex.P-A/1 was lodged u/s 302 P.P.C by Raza Muhammad S.I (PW-1) against the accused Zahir Jaffar. During course of investigation the complainant made supplementary statement and nominated the parents of the accused and others. The complainant made supplementary statement on 24.07.2021 in light of disclosure of accused Zahir Zakir Jaffar and nominated the accused namely Dileep Kumar, Wamiq Riaz, Samar Abbas, Amjad Mahmood, Abdul Haq as well.

The police added the sections 176/109/201/511 P.P.C and again after receiving the DNA report added sections 118/376/364/368 P.P.C.

Zakir Jaffar, Zakir Jaffar, Mst.Asmat Zakir Jaffar, Muhammad Iftikhar, Jamil Ahmad, Muhammad Jan, Tahir Zahoor, Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood were charged on 14.10.2021 u/s 302/376/364/368/201/511/109/176/118 P.P.C to which they pleaded not guilty and claimed trial, thereafter prosecution was directed to produce its evidence and the prosecution produced its evidence as under:

Raza Muhammad S.I, deposed that on 20.07.2021, he was posted in Police Station Kohsar and was present in Police Station, at about 11:00pm, Muhammad Abid Latif 80/LHC brought the complaint Ex.P-A to the Police Station duly drafted by Muhammad Zubair ASI for registration of case, upon said complaint he chalked out the FIR No.380/2021, u/s 302 P.P.C Ex.P-A/1. FIR is in his handwriting and bears his signature. He sent the original complaint and copy of FIR through Muhammad Abid Latif/LHC to SHIU for further proceedings.

Abid Latif 81/LHC, deposed that on 20.07.2021, he was posted in Police Station Kohsar Islamabad, on same day he alongwith Muhammad Zubair ASI and other police officials proceeded to House No.07, Street No.60, Sector F-7/4 Islamabad. After sometime the complainant of this case namely Shaukat Muqaddam came to the said place and Zubair ASI recorded the statement of complainant. He handed over the said statement/complaint to him. He went to the Police Station for registration of case. He handed over the said statement to Raza Muhammad S.I who chalked out the FIR and he handed over the copy of FIR and complaint to him. 

There was laceration over right temple, three lacerations on neck of right side, four stab injuries on left breast. Head was separated from the body. Multiple bruises on thigh and knees. X-ray of whole body was done. Detail post mortem conducted.

Specimens i.e. Heart, lungs, stomach with content, intestine, liver spleen, swabs (vaginal, anal, perineal rectal) and nails scrapping taken for toxicology, histopathology and DNA swabs taken to rule out sexual assault and handed over to the police.

Cranium and spinal cord, skull intact and healthy, vertebra slit at level of vertebra 3, spinal cord severed at vertebra 3 left. Brain intact and healthy. According to radiologist multiple ring shaped artifacts are seen. No bone injury was seen through the vault of skull and provided skeleton.

X-Ray of whole body was done. According to radiologist Dr.Maliha all bones and joints were intact and healthy except fracture of vertebra 3.

Final remarks: In her opinion, probable cause of death is lack of blood supply to brain due to separation of head from body.

According to forensic science laboratory report:

Toxicology drug and poison were not detected in liver and stomach content. Histopathology report reveals are branches of cornorie patent. The sections of myocardium were unremarkable. The lung section reveals dilated alvelie with presence of focal odematous fluid suggest labored respiration. DNA profile obtained from sperm fraction item No.1 is mixture of at least two individual Mst.Noor Muqadam and Zahir Zakir Jafar. Item No.S.1 cannot be excluded as being contributor to the DNA mixture profile.

Time between injury and death 5-10 minutes and time between death and postmortem is 9-10 hours. Postmortem report is Ex.P-AC duly signed her and bears her seal. Death certificate is Ex.P-AC/1 prepared by her bears her signature and seal. Inquest report duly endorsed by her is Ex.P-AC/2. Application to keep the dead body in mortuary is Ex.P-AC/3. Application for conducting postmortem is Ex.P-AC/4.

On 20.07.2021 at about 10:00pm a telephonic call was received from Police Station Kohsar informing that Noor Muqadam has been murdered and asked him to reach in Police Station Kohsar. He went to Police Station Kohsar and police took him to House No.07, Street No.60, F-7/4 Islamabad belonging to accused Zakir Jafar. He went inside the house and saw that his daughter Noor Muqadam done to death with a sharp edge weapon by separating her neck from her body. He identified dead body of his daughter. Accused Zahir Zakir committed brutal murder of his daughter. Zubair Mazhar recorded his statement Ex.P-A. I.O prepared the inquest report Ex.P-AC/2 which bears his signature and signature of Jawad Jahan. On 21 July 2021, he alongwith Jawad Jahan went to poly clinic hospital where they identified the dead body of Noor Muqadam at the time of post mortem examination. Dr.Shazia Nazir conducted the post mortem examination and he and Jawad Jahan received the dead body after post mortem examination vide receipt Ex.P-BC which bears his signature and signature of Jawad Jahan. On 23 July 2021, he made supplementary statement stating that the mobile phone with sim No.0333-3345059 of his daughter is not traced and requested to trace the mobile phone of his daughter. On 24 July 2021, at about 10:00pm, he and Jawad Jahan went to Police Station Kohsar where the investigation of accused Zahir Zakir was in progress in our presence. The accused Zahir Zakir informed that he snatched the mobile phone of Noor Muqadam which he kept and he could get it recovered. On disclosure of accused he led the police to his house No.07, Street No.60, F-7/4 and he alongwith Jawad Jahan accompanied. The accused Zahir Zakir took them to first floor of his house and he got recovered the mobile phone (P-56) from the wooden almirah of the eastern wall of south east room of said room and he produced before the I.O. He and Jawad Jahan identified the said mobile phone vide identification memo Ex.P-BD. The I.O prepared the recovery memo of said mobile phone and

As per CDR record accused Asmat Zakir and Zakir Jafar remained in touch with the accused Tahir Zahoor on the day of occurrence and he also nominated the accused Jan Muhammad and Tahir Zahoor.

Abdul Sattar Inspector, deposed that on 20.07.2021, he was posted as Incharge Investigation in SHIU City Zone Islamabad. On same day at about 10:00pm, he received information about the occurrence which took place at the House No.07, Street No.60, F-7/4 Islamabad. After receiving said information he alongwith his team proceeded to place of occurrence. When he reached at place of occurrence, Zubair Mazhar ASI alongwith other police officials, complainant and lady police officials were present at the spot. Accused Iftikhar and Jamil were also present at that house. The accused Zahir Zakir was arrested by the police officials present at the place of occurrence. Zubair Mazhar ASI recorded the statement of complainant and prepared complaint Ex.P-A which he sent to Police Station for registration of FIR. of PFSA Lahore comprising of four pages as Ex.P-BQ and Fire Arms Report of NFSA comprising of one page as Ex.P-BR. After closure of prosecution evidence the accused made their statements u/s 342 Cr.P.C on 09,02,2022 and in reply to the question why the PWs deposed against him then the accused Zahir Zakir replied as under:

"I am innocent. I and deceased were good friends since long and were in living relationship with mutual consent, same was also in the knowledge of both the families. Deceased participated in our family functions like family members and I was also used to attend her family functions and events. Six months prior from alleged occurrence I was not in contact with deceased and suddenly on 18.07.2021 deceased herself established contact with me and asked to arrange a drug party which I refused, but she proceeded to my house in the night of 18.07.2021 with a heavy quantity of drugs and insisted for the party as she wanted to invite her friends also in the party which she did and her friends also visited my house. My ticket for America was confirmed for 19.07.2021 and I left my house on 19.07.2021 for airport, but she insisted to quit the flight and she will also go to America with me. For that purpose she called her contacts and borrowed money for ticked on telephone. She forcibly returned the taxi driver to my home and I could not resist. On 20.07.2021, in the afternoon she also called her friends for drug party, her friends came to my home as I alone was in my home, my parents and other family members were at Karachi for Eid event. When the party started I became under the intoxication of drugs like all others including the deceased. I got out of senses and after the hours when I got senses I was in a tied up condition in the lounge of my house. After sometime, some persons in police uniform and civil dresses rescued me and I came to know that the Noor has been murdered by someone amongst the participants of drug party. Me and my parents are falsely roped in this case because the unfortunate event happened in my house. It will not the out of place to mention here that before the arrival of police and others, complainant and his relatives were also present in my house. He may also know better about the incident, but he has not been interrogated by the police in this context. Due to verbal firework of social media, before the recording the prosecution evidence I have been declared guilty and had badly been castigated because the complainant is an influential person and after this alleged occurrence complainant held a press conference alongwith state minister Mr.Shahbaz Gill and that was repulsive beyond words. State machinery alongwith media have been fully utilized against me for getting "Omnis Indemnatus robe innoxix legi bushabetur" every uncondemn person is regarded by law is innocent. Due to indulgence of state machinery investigating agency falsely roped my

One of member was injured by the main accused defense counsel initiated arguments. Mr.Muhammad Akram Qureshi advocate on behalf of the accused Tahir Zahoor argued that the accused sent his Therapy Since the accused produced their defense evidence and learned

accused Tahir Zahoor and the other workers of Therapy Works team except CDR. There are lot of contradiction in the prosecution evidence creating doubt. PW-8 Muhammad Imran forensic expert reached to the spot at 10:00pm and according to his statement the workers of Therapy Works did not destroy any evidence. Imran PW-8 did not take into possession the laptop from the spot. PW-2, PW-3 and PW-15 made their contradictory statements to the extent of arrival of police officials and complainant at the spot. In fact all the proceedings were conducted while sitting in police station, not at the spot. ExP-A reveals that ID card number and telephone number has subsequently been added. Zubair Mazhar ASI was not legally authorized to record the statement of complainant. The I.O has not mentioned the correct name and belt number of PW-7 in his statement u/s 161 Cr.P.C. In statement u/s 161 Cr.P.C (Ex.D-D) of Farasat Faheem PW-7 there is no mentioned regarding the receiving the parcel. PW-7 Farasat Faheem was on leave that is why he did not receive any parcel on 21.07.2021. The I.O did not prepare the recovery memos even he did not give the reason that why he got the recovery memos prepared from other officials. The prosecutions has failed to prove the save custody of parcels. All the prosecution evidence is contradictory and created doubt regarding arrival of police officers/officials at the spot and all the proceedings are dubious. The I.O conducted dishonest investigation, therefore the prosecution has failed to prove its case beyond any shadow of doubt. The accused be acquitted.

7. Mr.Sikandar Zulqarnain Saleem advocate and Mr.Shehryar Nawaz advocate being state counsel argued that there is no direct evidence of murder of Noor Muqadam. The case is based on circumstantial evidence. The prosecution has failed to complete the chain of circumstantial evidence. The prosecution has failed to prove its version. According to the complaint Ex.P-A the deceased was

missing from the house of complainant on 19.07,2020, in fact she was missing since 18,07,2021 as per charged framed by this court. There is delay in post mortem examination which is just to built-up the fake story. PW-8 Muhammad Imran forensic expert did not collect the blood stained shirt of accused Zahir Zakir from the spot it means that he was not in the custody of police as alleged. Muhammad Imran PW-8 dld not follow the forensic guideline. The dead body was not shifted to mortuary, it was taken emergency of Hospital. The Dr.Shazia did not conduct the post mortem. The date has not been mentioned on post mortem examination report. Dr.Hamad Hussain PW-13 conducted cursory medical examination of the accused, but he did not use to modern technique. The prosecution evidence is also contradictory to the extent of receiving sealed samples and arrival of the I.O and complainant at the spot. The recovery has been affected against the spirit of law. There is violation of section 103 Cr.P.C. The video clippings have been produced with own choice of I.O and not produced the entire video clips. The prosecution has failed to establish its case against the Zahir Zakir.

the accused Zakir Jaffar and Mst. Asmat Zakir argued that the accused Zakir Jaffar and his wife Mst. Asmat Zakir have been nominated in supplementary statement dated 24.07.2022 and the other two accused namely Muhammad Jan and Tahir Zahoor were nominated in supplementary statement dated 08.08.2021. Supplementary statements have no value in eye of law. The offence of abduction as well as illegal confinement has not been proved at all. The accused Zakir Jaffar, Mst. Asmat Zakir were not present in Islamabad and they were in Karachi. They came to Islamabad and they themselves went to Police Station on 21.07.2021. The accused Zakir Jaffar and his wife have been involved on the basis of CDR and the said CDR is doubtful because the CDR has not been got verified

by concern company. The I.O has failed to mention the main gate as well as installation of DVR in his site plan. The prosecution has failed to produce any representative of any company to establish the veracity of CDR. PW-12 took only prints of the CDRs on different dates, he did not prepare the CDR, but his statement u/s 161 Cr.P.C recorded once. The I.O has not mentioned the correct name of PW-7 and his belt number. He is planted witness just to strengthen the case. The accused Zakir Jaffar as per CDR was in contact with the complainant and this fact has been concealed. The prosecution evidence is contradictory and not reliable. Mr. Asad Jamal advocate further added that the prosecution has concealed facts regarding the receiving of information of the occurrence, even the prosecution has not disclosed the actual time of murder of Mst.Noor Muqadam. Similaryly, the time of death mentioned in post mortem report Ex.P-AC also created doubt in the prosecution story. The time mentioned in FIR Ex.P-A/1 is 10:00pm which has not been proved by the prosecution through strong evidence. The subsequent application Ex.P-BF dated 24.07.2021 nominating the accused is against the provision of articles 38, 39 and 17 of Qanoon-e-Shahadat 1984. Mst.Asmat Zakir and Zakir Jaffar proceeded to Karachi from Islamabad on 17.07.2021 and they were not at Islamabad. The police department has no authority to tap the telephone of any citizen because it is against the fundamental right of the citizen.

9. Mr.Sajjad Ahmed Bhatti advocate on behalf of the accused Jameel Ahmed, Muhammad Jan, Muhammad Iftikhar argued that the said accused were not nominated in the FIR and no specific role has been attributed to them. They have been nominated on the basis of subsequent application Ex.P-BF which is afterthought with due deliberation. The said application is based on disclosure of under arrest co-accused based on malafide. PW-5 draughtsman did not show the



As per statement of PW-6 the articles recovered at the time of personal search of aforesaid accused have not been deposited with the Moharrar. The alleged CDR data does not bears the phone number and companies name. PW-15 stated that the dead body was taken to PIMS whereas other witness stated that dead body was taken to poly clinic hospital. Dr. Usman conducted external post mortem of the body, but he has not been produced as witness. The accused Jameel Ahmed, Muhammad Jan, Muhammad Iftikhar being employees in said house did not commit any offence. They did not abduct or wrongfully confine Mst. Noor Muqadam. The entire evidence of prosecution is contradictory, therefore, benefit of doubt be given to the accused and they be acquitted.

Mr.Shahzad Qureshi advocate on behalf of the accused Daleep 10. Kumar, Samar Abbas, Abdul Haq, Wamiq Riaz and Amjad Mehmood argued that according to the DVR they reached to the spot at 08:00pm (PST) for medical intervention. The complainant had watched the DVR on 20.07.2021, but he did not nominate the said accused in the FIR. The complainant nominated the aforesaid accused on 24.07.2021 on disclosure of main accused Zahir Zakir. In the said disclosure the accused raised serious allegations against his parents and workers of Therapy Team, but said disclosure during police custody has no value in eye of law. According to the statement of PW-8 Muhammad Imran of NFSA the worker of Therapy Works did not destroy the evidence. Amjad Mehmood accused received injuries at the hands of accused Zahir Zakir, but the prosecution made the worker of Therapy Works as accused instead of witnesses. The Therapy Works team hold the accused Zahir Zakir for about 25 minutes at the spot, thereafter the police reached to the spot, even then the police did not added offence u/s 324 P.P.C. As per prosecution evidence the DVR and CCTV

to remove the said DVR and cameras from the spot despite they could do so.

They did not commit any offence, therefore, they be acquitted.

The learned defense counsel relied upon 2021 SCMR 522, 2003 SCMR 1419, 2014 SCMR 749, PLD 2016 S.C 951, 2016 SCMR 274, PLD 2020 S.C 523, 2017 SCMR 898, 2018 SCMR 313.

On the other hand, Mr. Hassan Abbas ADDP and Mr. Shah Khawar 11. advocate on behalf of the state/complainant argued that the complainant received fresh information during investigation that is why he made supplementary statements. The complainant did not know the names of accused when he reached to the spot first time. The said movement was mournful for him and after burial of his daughter, he went to police station and then he made supplementary statement. The accused have themselves admitted the place of occurrence, arrival of Mst. Noor Muqadam in the house of accused Zahir Zakir as well as arrival of police at the spot in their statements u/s 342 Cr.P.C, therefore minor contradiction in the statements of police officials do not fatal the case of the complainant. CCTV footage/recording is available in the evidence which depicts the time of arrival of police officials, I.O as well as the complainant. The DVR was played in open court and same depicts the role of each accused visible in said DVR. Accused Zakir Jaffar and Mst. Asmar Zakir continuously remained in touch with their son accused Zahir Zakir and co-accused Tahir Zahoor. This fact is very clear from the CDR of the accused. The accused Zakir Jaffar and Mst.Asmar Zakir passed on instructions to the accused Tahir Zahoor and accused Tahir Zahoor instructed his Therapy works team to destroy the evidence while reached at the spot. Fortunately police reached to the spot, otherwise they would have remove the dead body of Noor Muqadam as well as main accused

Zahlr Zakir from the place of occurrence, The reports of PFSA and FIA are positive and supporting the prosecution version. According to article 17 of Qanoon-e-Shahadat Ordinance, 1984 one witness is sufficient to prove the fact. The complainant received the information at 10:04pm from the police station and he was residing at a long distance from the house of occurrence. Thereafter, he reached to the place of occurrence. If the police officials had made contradictory statements to the extent of time of arrival of the complainant at the spot, then such contradiction is not material because documentary evidence in shape of DVR is available in evidence. The PFSA report reveals that the deceased Noor Muqadam did not use any drug and was administered any poison. The accused took summersault in their statements u/s 342 Cr.P.C. The accused Zahir Zakir under the advice of his counsel stated that the drug parties were being arranged in the house of occurrence, even if so the parents of the accused were responsible for allowing their son to do illegal activities in the house. Moharrar PW-6 received the parcels and he handed over the parcel on 29.07.2021 and 30.07.2021 for onward transmission to FIA and PFSA. The statements of the Moharrar of PW-6 were recorded u/s 161 Cr.PC after depositing in parcels in the concern corner, therefore, there is no illegality. PW-12 Jabar being computer operator received the email on computer system and then download the CDR, thereafter, he got the CDR printed. Therefore, he is the concern witness which was produced by the prosecution in the witness box to prove the genuineness of CDR. They further argued that the all the prosecution evidence was recorded in presence of the accused as well as the learned state counsel. On 17.01.2022 the learned senior state counsel conducted cross-examination through online, but before that his associate made different applications which were decided by the court, the accused Zahir Zakir and state counsel Mr.Shehryar Nawaz advocate were present in the court. The accused Zahir Zakir was not feeling well on said

day and associate of the senior state counsel made application for his medical treatment. Due to this reason he was sent back to the lock up to get treatment. Even then the Zahir Zakir on advice of his state counsel stated that some evidence has been recorded in his absence which is against the ethics. The accused Zahir Zakir is mentally fit person and not mentally disordered. He played different types of drama during trial proceedings. The court dismissed the application for declaring him mentally disordered person vide order dated 05.01.2022 and the said order is intact. The prosecution has produced sufficient, cogent evidence to prove its case beyond any shadow of doubt. The police witnesses are competent witness and their testimony cannot be discarded. They relied upon PLD 2019 S.C 675, PLD 2021 S.C 550, 2008 SCMR 1228, 1998 P.Cr.L.J 114, 1998 SCMR 1778, 2021 SCMR 531 and they prayed for maximum sentence to all the accused.

Arguments heard, record perused.

Shaukat Ali Muqadam (PW-18) made his oral statement Ex.P-A reduced into writing by Muhammad Zubair Mazhar ASI (PW-15) at the spot i.e. House No.07, Street No.60, Sector F-7/4 Islamabad, where he reached after receiving the information of murder of his daughter Noor Muqadam. As per version of the complainant set forth in statement Ex.P-A and FIR Ex.P-A/1, he went to Gulraiz, Rawalpindi on 19.07,2021 at afternoon to purchase goat for immolating, whereas his wife went to F-10 markaz to collect her clothes from tailor. He came back to his home at Magrib prayer time, but his daughter Noor Muqadam (deceased) aged about 27/28 years was not present in the house. His wife in the meantime, also came back to home who made telephonic call to Noor Muqadam at her cell No.0333-3345059 which was found switched off, whereupon they got worried

and started searching their daughter. They also contacted to the friends of N_{00r} Muqadam. In the meantime, Noor Muqadam made telephonic call that she is going to Lahore with friends and will come back in 1-2 days. On 20.07.2021, accused Zahir Zakir with whose family the complainant had acquaintance, telephonically informed that Noor Muqadam is not with him. At about 10:00pm the complainant received telephonic information from Police Station Kohsar regarding the murder of his daughter. Careful scrutiny of evidence and record reveals that this is not case of direct evidence, this is case of circumstantial evidence mostly based on modern techniques and forensic evidence. According to the complaint Ex.P-A the complainant when came back to his home on 19.07.2021 from Rawalpindi his daughter was not present in the house. The complainant did not state in his statement Ex.P-A that his daughter was missing from his house on 19.07.2021. During investigation I.O PW-19 recovered DVR from the house of the occurrence and the recording relating to the occurrence was saved in hard disk. The parcel of DVR (P-13) and parcel of hard disk (P-14) was taken into possession by the I.O vide recovery memo Ex.P-T. The DVR connected with eight CCTV cameras, was installed in the house of occurrence bearing No.07, Street No.60, sector F-7/4 Islamabad. The CCTV footage saved in DVR and hard disk was played on the court computer system during crossexamination of I.O PW-19 on request of learned defense counsel. The said house is owned by the accused Mst.Asmat Zakir. The said piece of evidence is modern scientific evidence. The DVR was collected from TV lounge of the house of accused and PW-17 Mudasar Alim saved the CCTV footage relating to the occurrence in hard disk (P-14). The parcels of DVR and hard disk were sent to PFSA Lahore for forensic and photogrammetry test. The accused was also produced in the PFSA Lahore. The report of PFSA Ex.P-BH regarding audio visual analysis is positive which shows the genuineness and authenticity of

CCTV footage saved in DVR and hard disk. According to the photogrammetry tests the facial features of accused Zahir Zakir matched with the person seen in the video. According to P-13 and P-14, Mst. Noor Muqadam arrived in the house of occurrence on 18.07,2021 along with her purse and not with any luggage. The mode of arrival of deceased Mst. Noor Muqadam revealed that she had already acquainted with the accused Zahir Zakir as well as with the said house. Mst.Noor Muqadam (deceased) remained in said house from 18.07.2021 to 20.07.2021 and during this time she went out the house and then came back with the accused Zahir Zakir. At the time and date of murder of Mst.Noor Muqadam the accused Zahir Zakir was present in the room of his house. As per evidence the dead body of Mst. Noor Muqadam was found in the room of accused Zahir Zakir. The place, date and time of occurrence has been proved by the prosecution through modern device and sufficient evidence, even otherwise the date and place of occurrence has not been denied by the accused as well. Muhammad Imran Crime Scene officer NFSA (PW-8) went to the house of occurrence and he proceeded to the room situated in first floor of house of occurrence where the dead body of Mst. Noor Muqadam was lying beheaded. The crime scene was intact till that time and PW-8 took under nails swab of both hands of the dead body, collected buccal swab from the mouth of deceased, collected swiss knife (offence weapon) P-4, iron knuckle from the table, pistol alongwith magazine, four cigarettes butts from the said room and prepared the parcels. Subsequently the said parcels were sent for forensic analysis. The Investigating officer PW-19 also inspected the place and he prepared un-scaled site plan Ex.P-BG and he has shown the place where the dead body of Mst. Noor Muqadam was lying in the room of accused Zahir Zakir, then the police shifted the dead body to hospital for post mortem examination. According to the evidence, on direction of accused

Tahir Zahoor Therapy Works Team comprising of accused Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood went to the place of occurrence much before the arrival of police. According to the CCTV footage of DVR (PW-13), hard disk (P-14) the Therapy Works team apprehended the accused Zahir Zakir. The accused Zahir Zakir also caused injury to the accused Amjad Mehmood when he entered in the room of accused Zakir Zahir while leading the Therapy Works team. The prosecution evidence makes it clear that the accused Zahir Zakir was found in the room of occurrence alongwith dead body. The accused Zahir Zakir committed murder of Mst.Noor Muqadam in his room situated in upper portion of the house. He committed murder of Mst.Noor Muqadam with swiss knife P-4 by separating her head from the body. The offence weapon was also recovered from the spot. All these aspects establish that the accused Zahir Zakir committed intentional murder of Mst.Noor Muqadam.

13. According to the evidence of prosecution Mst.Noor Muqadam with her own will came to the house of accused Zahir Zakir on 18.07.2021 at about 10:18pm (DVR time which is 35 minutes in advance from Pakistan Standard Time). She left the said house on 19.07.2021 alongwith accused Zahir Zakir having luggage and went away while boarding in a car standing outside the house. Again the accused Zahir Zakir and Mst.Noor Muqadam came back to the said house at about 02:40am (DVR time). Thereafter, Mst.Noor Muqadam went inside the house and she attempted to save her life, but she was not allowed to go out the said house by the accused Iftikhar (watchman). The said watchman was present at the main gate and he closed the main gate. The accused Zahir Zakir overpowered Mst.Noor Muqadam who beseeched him to let her go, but the accused Zahir Zakir forcibly took her inside the room of his house. Mst.Noor Muqadam lastly attempted to save her life on 20.07.2021 at about 07:12pm (DVR time) when she jumped from the room situated at first floor through the window

of washroom and she fell on the grills at ground floor. She rushed towards the main gate having mobile phone in her hand to save her life, but the accused Muhammad I(tikhar (watchman) and the accused Muhammad Jan (gardener) did not allow her to go outside the house. The accused Muhammad Jan closed the main gate and the accused Muhammad Iftikhar then proceeded to basement. The accused Muhammad Jan (gardener) remained present at the main gate. Mst.Noor Muqadam tried to open the main gate, but he did not allow her. CCTV footage further reveals that accused Zahir Zakir reached there and he overpowered Mst.Noor Muqadam and locked her inside the room/cabin of watchman situated inside the house near the main gate. He also snatched her mobile phone, then the accused Zahir Zakir unlocked the said cabin and forcibly took Mst.Noor Muqadam inside the house. It is made clear that Mst.Noor Muqadam came to the said house with her own consent, but the accused Zahir Zakir overpowered her and did not allow her to leave the house and he forcibly took her to his room in order to murder her. As per law offence of abduction was committed at that time. It is well settled law when a person is forcibly or deceitfully moved even for a one step, then the offence of abduction is made out. The accused Zahir Zakir took Mst. Noor Muqadam forcibly in his room and lastly wrongfully confined her, therefore, as per evidence of prosecution it is proved that the accused Zahir Zakir abducted Mst, Noor Muqadam from main gate and forcibly took her inside the house and then wrongfully confined her in his room and lastly committed her murder. The evidence further reveals that the accused Zahir Zakir kept Mst. Noor Muqadam in his room from 18.07.2021 to 20.07.2021 and during this period she attempted to save her life by making attempts to flee away, but she was overpowered by the accused Zahir Zakir and she was subjected to rape. According to PFSA report Ex.P-BL the seminal material was

identified on vaginal swab from Mst.Noor Muqadam. The DNA profile obtained from sperm fraction matched with the DNA profile of Zahir Zakir, According to the report of PFSA, it can safely be said that Mst.Noor Muqadam was subjected to rape by the accused Zahir Zakir.

14. It is worth mentioning there that during the trial proceedings the learned state counsel made effort to get the accused Zahir Zakir declared mentally disordered person just to save the accused from legal punishment. The application was moved to declare the accused mentally disordered person which was dismissed on 05.01.2022. Again the learned state counsel moved application on 15.01.2022 for medical treatment of Zahir Zakir and the said original application was sent to superintendent jail with direction to get the accused medically examined from jail hospital. The accused was medically examined in jail hospital and the medical report dated 17.01.2022 was received to the court. As per medical report, the medical officer of jail hospital found the health condition of accused Zahir Zakir as satisfactory. It is further mentioned there that Mr.Shehryar Nawaz advocate was appointed as state counsel, later on Mst.Sikandar Zulqarnain Saleem advocate appeared in the court from Lahore, he was also appointed as state counsel, but he was arranged, managed and produced by the family members of the accused Zahir Zakir who were intouched in pursuing his case. The best reason known to the learned state counsel that why he did not submit the power of attorney on behalf of the accused Zahir Zakir and preferred to opt to be a state counsel. P-13 and P-14 are sufficient to show the mental as well as physical fitness of accused Zahir Zakir at the time of occurrence. The CCTV footage shows the tenor, manner and movement of the accused Zahir Zakir like a healthy and fit person. He looked like a well oriented person. No previous medical history regarding mental health of the accused was produced before the Magistrate and before the trial court. The accused Zahir

Zakir himself produced a USB in his defense evidence as ReDA which reveals that the accused was dancing in a party with Mat.Noor Milgadam (deceased). The said video clip produced by the accused shows that he is well oriented having good physical and mental condition.

So far as concern to the accused Jamil Ahmad (cook), Muhammad 15. Jan (gardener), Muhammad Iftikhar (watchman), they are not nominated in the FIR. The FIR was lodged promptly after recording the statement of complainant Ex.P-A, when he reached to the spot after receiving the information from police station Kohsar. He received the information at about 10:00pm and thereafter, be reached to the spot. Obviously, when he saw the dead body of his daughter he was in shocking condition. He did not know all the facts and information of the case, later on, he made supplementary statements and he nominated the accused Iftikhar the watchman, Muhammad Jan the gardener and Jamil Alimad the cook. The said accused were performing job in the house of accused Zahir Zakir. The prosecution has produced modern scientific evidence against them in shape of DVR P-13 and hard disk P-14. According to the evidence of prosecution available on record the accused Muhammad Iftikhar and Muhammad Jan are visible at the house of occurrence. Their roles are also depict from the said evidence. According to the evidence Mst. Noor Muqadam deceased entered in the house of accused Zahir Zakir on 18.07.2021 at night time and accused Muhammad Iftikhar watchman was present at the main gate of sald house. Mst.Noor Muqadam as per CCTV footage tried to go outside the house barefooted in a stress condition on 19.07.2021 and at that time accused Muhammad Iftikhar watchman was present at the main gate who closed the main gate. In the meantime, accused Zahir Zakir rushed towards the Noor Muqadam and he overpowered her. Mst.Noor Muqadam beseeched him to allow her to go, but the accused Zahir

limped towards the main gate to escape, but the accused Muhammad Iftikhar and Muhammad Jan did not allow her to go outside the main gate and the accused closed the main gate. The accused Muhammad Iftikhar went to the basement and accused Muhammad Jan remained present at the main gate. Mst.Noor Muqadam tried to open the gate, but he did not allow her. In the meantime, accused Zahir Zakir reached there who forcibly took Mst.Noor Muqadam in his room. He abducted her in order to murder her and wrongfully confined in the room. In this scenario the accused Muhammad Iftikhar and Muhammad Jan facilitated the accused Zahir Zakir and abetted him in commission of offence of abduction. The evidence further reveals that the, accused Muhammad Iftikhar and Muhammad Jan did not inform the police and concealed this fact. The accused Muhammad Iftikhar and Muhammad Jan had watched the cruel treatment of Zahir Zakir towards Mst. Noor Muqadam, even then they did not bother to inform the police. It was their legal as well as moral duty to inform the police and they omitted to fulfill their legal as well as moral duty. Similarly, they concealed the design to commit the offence subsequently committed by the accused Zahir Zakir. So far as concern to the allegation of abetment of murder, they were servants in the said house and obviously they were not in dominating position as regard to their master. They did not know what was happening inside the room of accused Zahir Zakir, therefore, they have not hatched any conspiracy of murder of Mst. Noor Muqadam and they did not abet the offence of murder. The prosecution has also established the case against the accused Muhammad Iftikhar and Muhammad Jan. But the prosecution has failed to prove that they abetted the offence of murder of

Mst.Noor Muqadam, therefore charge u/s 109/302 P.P.C is not proved against them and they are not entitled for conviction in the said charge u/s 109/302 P.P.C. So far as concern the objection raised by defense side that the offence u/s 176 P.P.C is not cognizable by the police, it is submitted that the other offences are cognizable by police, therefore, there is no legal bar to chalk out the FIR as well as to investigate the offence u/s 176 P.P.C alongwith other cognizable offences. So far as concern to the accused Jamil Ahmed (cook), there is no evidence against him regarding the commission of offence, he is not visible in the CCTV footage, even he was not performing his duty at main gate. He remained inside the house, but no evidence is on record to sift out his role in commission of the offence. The prosecution has failed to establish that the accused Jamil Ahmad has abetted and facilitated the accused Zahir Zakir for commission of the offence.

So far as concern to the accused Zakir Jaffar and Mst. Asmat Zakir 16. they are husband and wife and parents of main accused Zahir Zakir. According to the prosecution evidence Mst. Noor Muqadam came to the house of the accused on night of 18.07.2021 and she remained there till her murder on 20.07.2021. It is an admitted fact that the accused Zakir Jaffar and Mst.Asmat Zakir were not present in the house of occurrence from 18.07.2021 to 20.07.2021 as they had gone to Karachi. The complainant made his supplementary statement and application Ex.P-BF in which he nominated the accused Zakir Jaffar, Mst. Asmat Zakir Jaffar alongwith Muhammad Iftikhar, Jamil Ahmad, E 19 O SPICI & SPENOWS JUDGE 4 - 2 Dileep Kumar, Wamiq Riaz, Samar Abbas, Amjad Mahmood and Abdul Haq on 24.07.2021. According to the version of prosecution the accused Zakir Jaffar and Mst.Asmat Zakir had knowledge about the murder plan hatched by their son namely Zahir Zakir and they did not inform the police and facilitated their son.

The prosecution to connect them with commission of offence, produced CDR

Scanned with CamScanner Scanned with CamScanner data as P-52/1-58, P-55/1-29. No doubt according to the CDR data of accused Zakir Jaffar and Mst. Asmat Zakir they were in Karachi and were in connection with their son Zahir Zakir as well as with the accused Tahir Zahoor. The defense side raised objection regarding said CDR data that the concern representative was not produced before the court. The defense side further objected that the police has no authority to tap the telephone of any citizen, because it is against the fundamental right. It is submitted that the collection of CDR data is quite different from the tapping of telephone of citizens. The learned defense counsel has not followed the difference between the tapping of telephone of any citizen and collecting the CDR data of any person involved in any crime to establish his involvement. It is further submitted that the request was forwarded by the police, whereupon the police received the CDR data of accused through email. PW-12 performed duty as computer operator in SP Islamabad. He downloaded the said CDR data and then printed out. He handed over the aforesaid CDR data to the I.O. There is no text message as well as the transcript of voice call to establish the actual conversation between the main accused and his parents. Mere on the basis of telephonic connection of accused Zakir Jaffar and Mst.Asmat Zakir with their son Zahir Zakir, it cannot be presumed that they passed on the instructions to kill Mst.Noor Muqadam or passed on the direction to Tahir Zahoor to destroy the evidence. Without text message, voice message/conversation it cannot be presumed that the accused Zakir Jaffar and Mst.Asmat Zakir while sitting in Karachi had facilitated and abetted their son in commission of murder, abduction, wrongful confinement. There is no strong and solid evidence to prove that they had knowledge that their son was going to commit murder of Mst.Noor Muqadam. Firstly, it was duty of prosecution to establish that the accused had knowledge of the plan of their son, then the legal

the life of Mst.Noor Muqadam. Mere on the basis of simple CDR the court cannot presume that they are involved, participated in any manner in the crime committed by their son. Therefore, prosecution has failed to establish the case against the accused Zakir Jaffar and Mst.Asmat Zakir and they cannot be convicted merely on the basis of CDR data.

17. Now comes to the role of accused Tahir Zahoor and his Therapy Works team comprising of Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood. The accused Tahir Zahoor is head of the Therapy Works and as per prosecution version he received instructions from the accused Zakir Jaffar and Mst. Asmat Zakir who were present in Karachi, to go to their house No.07, Street No.60, Sector F-7/4 Islamabad and on instruction of accused Zakir Jaffar and Mst. Asmat Zakir, he sent his Therapy team comprising of Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood. As per prosecution version the accused Tahir Zahoor received telephonic information from Zakir Jaffar and Mst.Asmat Zakir regarding murder plan made by main accused Zahir Zakir and he did not inform the police and abetted the offence committed by the accused Zahir Zakir. As per evidence it is an admitted fact that Tahir Zahoor received telephonic instruction from accused Zakir Jaffar and Mst. Asmat Zakir then he send the accused Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood to the House No.07, Street No.60, Sector F-7/4 Islamabad. The accused Tahir Zahoor himself did not go to the house of occurrence, whereas other team members went to the house. The evidence against the accused Tahir Zahoor is only based on CDR data P-53/1-58. The prosecution has not produced any text message or voice message, its transcript to establish the conversation between the accused Zakir Jaffar, Mst.Asmat Zakir and the accused Tahir Zahoor. Without such solid evidence it

Mere on the basis of CDR, it cannot be said that prosecution has establish that the accused Tahir Zahoor facilitated the accused Zahir Zakir and he failed to provide information to the police regarding the crime of the accused Zahir Zakir. Admittedly the accused Dileep Kumar, Wamiq Riaz, Samar Abbas, Abdul Haq and Amjad Mahmood went to the house of occurrence and their arrival is very much visible from CCTV footage saved in DVR P-13 and hard disk P-14. According to the evidence available on record the accused Amjad Mehmood received injuries and his companions took him in injured condition outside of house of occurrence and shifted to a van standing outside the main gate. According to the statement of Muhammad Imran Crime Scene officer NFSA, the crime scene was intact when he visited the spot. The accused did not remove anything from the crime scene. They shifted the injured Amjad Mahmood outside the said house and did not attempt to cause any disappearance of anything inside the room of occurrence. As per CCTV footage the main accused Zahir Zakir was tied with ropes and piece of cloth and the said accused (members of Therapy Team) also saw the dead body lying in the room. Obviously when the accused Amjad Mahmood received injuries then the members of Therapy team rushed to save the companion, but before the arrival of Therapy Team at the house of occurrence Mst.Noor Muqadam had been done to death by the accused Zahir Zakir. In theworried and shocking condition the members of Therapy Team could not inform the police immediately. In fact, it is the natural phenomenon when a companion had received injuries and the other team members had to save the life of the injured. As per persecution's evidence the Therapy Team did not attempt to cause disappearance or destroy any evidence from the crime scene, therefore, the

prosecution has failed to establish the case against the accused Tahir Zahoor, Daleep Kumar, Wamiq Riaz, Sammar Abbas, Abdul Haq and Amjad Mehmood.

So far as concern of the defense side, many technical objections 18. were raised, but the technical aspects regarding defective investigation has no value in light of the modern device and scientific evidence. The police witnesses made some contradictory statements regarding the time of arrival of the police officials and complainant at the place of occurrence. It is submitted that the oral statement has no value in light of documentary evidence in shape of P-13 and P-14. The CCTV footage P-13 and P-14 made clear all the contradiction pointed out by learned defense counsel. The defense side also pointed the loop-holes and lacunas in the investigation. The court observed that the I.O committed mistakes and left loop-holes during investigation. The I.O got drafted the recovery memos through his colleagues or sub-ordinates without giving reason. The question arises that whether the defective investigation is enough to spoil the case of prosecution/complainant. In this regard it is submitted that the Hon'ble Supreme Court of Pakistan in judgment cited as 2008 SCMR 1228 held that discrepancy reflected on the working and lethargy of the I.O could not cause any harm to the prosecution's case. In the said case the I.O did not take into possession the blood stained clothes of the deceased, blood stained earth, empties from the place of occurrence. Similarly, the Hon'ble High court in judgment cited as 1998 P.Cr.L.J 114 held that procedural defect or irregularity or even illegality in course of investigation shall not demolish the case of prosecution. Broadly speaking the discrepancies and contradiction as pointed out by defense side are not material and such contradiction and discrepancies are not fatal to case of complainant. The procedural defect and irregularity might have been done by the I.O during investigation to give undue favour to the accused

and the police authority at the most may take action in this regard. The police authority must think over it to take positive steps for reforms in the investigation wing of police department. The prosecution has produced its sufficient evidence in shape of modern scientific and forensic evidence to establish Its case that the Mst.Noor Muqadam was done to death by the accused Zahir Zakir inside his room. The dead body was recovered from the room of accused Zahir Zakir. Even the accused (the members of Therapy Team) had seen the dead body lying in the said room. The defense side has failed to rebut the evidence of prosecution. The defense also failed to establish that the dead body was not recovered from the said room of accused Zahir Zakir or the deceased Mst. Noor Muqadam was done to death at somewhere else. According to the reports of PFSA Ex.P-BM relating to Forensic toxicology, drugs/poison were not detected in the liver and stomach contents of deceased sent to the laboratory and as per PFSA report Ex.P-BL the DNA profile of the accused is also matched and accused Zahir Zakir cannot be excluded being contributor to DNA mixture profile. As per statements of PW-6 and PW-7 the sealed parcels were kept in save custody and transmitted to concern authority/laboratory. The medical evidence also supports the prosecution version as the cause of death is lack of blood supply to the brain due to separation from head from the body. The defense evidence as well as point raised by defense side has no weightage in front of the heavy flow of the prosecution evidence.

19. The nutshell result of above said discussion is that the prosecution has succeeded to establish the case against the accused Zahir Zakir, Muhammad Iftikhar (watchman) and Muhammad Jan (gardener) only. The prosecution has failed to establish its case against the accused Zakir Jaffar, Mst.Asmat Zakir Jaffar, Tahir Zahoor, Dileep Kumar, Wamiq Riaz, Abdul Haq, Samar Abbas, Jamil Ahmad and Amjad Mahmood, therefore, they are acquitted of the charges

leveled against them. The case property be disposed off in accordance with law, after period of appeal/revision, if any. The articles recovered from the personal possession of the accused Mst.Asmat Zakir and Jameel Ahmed are already with them. The articles recovered from the other acquitted accused be handed over to them. The vehicle/car No.ACJ-240 ICT, recovered from the accused Zakir Jaffar is on Supardari, therefore, Supardari Namas are discharged. The accused Zakir Jaffar is in jail, superintendent jail be informed accordingly to release him if not required in any criminal case. He also committed rape of Mst.Noor Muqadam. Therefore, the accused Zahir Zakir is hereby convicted:

i. U/S 302(b) P.P.C and is sentenced to death as Tazir. He be hanged by his neck till he is dead. He is directed to pay Rs.500,000/- (Five lacs) as compensation to the legal heir of the deceased Mst.Noor Muqadam as required U/S 544-A Cr.P.C. In case of non-payment of compensation amount it shall be realized as arrears of land revenue. In case of non-realization of said amount the convict shall have to undergo Six Months (06) S.I. However the death sentence awarded to the convict will be subject to confirmation by the Hon'ble Islamabad High Court, Islamabad. Reference U/S 374 Cr.P.C be immediately submitted to the Hon'ble Islamabad High Court, Islamabad for confirmation of the awarded sentence.
